Any member under a primary builder or associate member is considered an affiliate. Cost for the first affiliate member under a company is \$200.00 annually if paid by check or \$220.00 if paid by Credit Card and each affiliate after the first affiliate is \$60.00 each if paid by check and 75.00 if paid by Credit Card. The renewal anniversary for all members will be the same month the following year in which you joined.

IMPORTANT NOTICE

Dues payments to North Texas Home Builders Association are not deductible as charitable contributions for federal income tax purposes. However, dues payments may be deductible as ordinary and necessary business expense, subject to an exclusion for lobby activity. Because a portion of your dues is used for lobbying by NAHB (19% or \$37.62) and TAB (80% or \$120.00) for Builder and Associate Members and NAHB (\$3.00), TAB (\$2.20) for affiliate members is not deductible for income tax purposes.
